Crossover Legislative Update

The New Hampshire Legislature has completed the first half of its work and will now enter the final five weeks of the session. The NH Association of Counties started the session tracking 320 LSR's with 111 priority bills. Each of these bills has had a hearing and vote on the floor. A quick review of the priority bills shows that there are forty-six priority bills that have crossed to the other body for continued work. Many of these bills have been amended to make them better, but a few are still concerning.

HB 1210 - relative to exemptions from vaccine mandates

This bill includes conscientious objector language as an exemption to the federal vaccine
mandate. This bill as amended will place federal funds at risk for the county nursing homes.
 While the tune has changed in the House since it passed this bill, the Senate will need to
serve as the stop gap for vaccine bills that put federal funding at risk.

HB 1296 - relative to the forfeiture of items used in connection with a drug offense

• This bill as introduced did not impact county government but was amended at the Executive Session to place the burden of post-conviction litigation on the county attorneys' offices for the return of real property. This currently resides in the AG's office and the county attorneys believe that is where it should remain. The NHAC will take a more active position in the Senate.

Crossover Legislative Update cont...

HB 1397 - relative to the length of terms for Rockingham County officers

This bill would create a 4-year term for Rockingham's Register of Deeds, County Attorney,
County Treasurer and County Sheriff. The Senate Election Law Committee has asked NHAC and
NHMA to see if there is a way through warrant articles to get voter input into the process of
altering the length of terms for officers. The Committee has not acted on the bill waiting for
NHMA and NHAC to complete their research.

HB 1455 - relative to State enforcement of federal vaccination mandates.

This is Speaker Packard's bill and, similar to HB 1210, puts federal funds at risk by prohibiting
the state from enforcing a vaccine mandate as a requirement of employment. The Speaker did
say that the bill was filed prior to the ruling from the Supreme Court and as such he is open to an
amendment.

HB 1540 - relative to recording custodial interrogations

This bill has been altered dramatically since it was introduced. It now only requires an audio
recording of an interrogation and allows financial costs as a reason to not record. However, the
financial costs decision depends on a judge's discretion and may overrule a decision made by
the county commissioners.

HB 1604 – including state medical facilities in the statute providing medical freedom in immunizations

• This bill has also been drastically amended. The conscientious objector language has been removed from the bill, leaving only the religious and medical objections. The nursing home administrators have reviewed the amended language and believe that they can make it work with their existing policies. There is a desire to tighten up the religious exemption language to follow the CMS requirements and language.

Crossover Legislative Update cont...

SB 227 - relative to death benefits for first responders who die from suicide

• This bill adds suicide to the killed in the line of duty benefit and adds in correctional officers. The House has companion language that also passed, so it is anticipated that the bill will head to the Governor's desk.

SB 294 - relative to the release of a defendant pending trial

• The Senate and the House both introduced bail reform bills. The Senate version seems to be the version that is further in the process as it is the more compact version and only targets certain offenses committed while out on bail.

In the last five weeks of the session, the Senate and the House will hold hearings and vote on bills. The final date for action on the floor is May 5th, with the remainder of May being focused on the committees of conference.
