- I. Call to order
 - a. Commissioner Maglaras calls the meeting to order at 11:35 finding a quorum fit to conduct business.

Ms. Horgan takes the roll: Commissioner Omer Ahern, Commissioner Tom Brady (via Administrator Fish proxy), Commissioner Brian Chirichiello, Commissioner Robert Englund, Commissioner Steven Goddu, Commissioner Raymond Gorman (via Administrator Fish proxy), Commissioner George Maglaras, Commissioner Toni Pappas, Commissioner Deanna Rollo, Commissioner Robert Rowe (via Commissioner Pappas proxy), Commissioner Robert Theberge (via Administrator Fish proxy), Commissioner Robert Watson (via Commissioner Maglaras proxy), Commissioner Jack Wozmack; Commissioner Jennifer Fish of the public; and Danielle Duchesne and Kate Horgan of the Dupont Group/Rumford Management.
- II. Approval of past meeting minutes
 - a. Commissioner Maglaras presents the minutes from the November 4, 2022 meeting of the Officers. Commissioner Pappas makes a **MOTION** to approve the minutes. Commissioner Chirichiello **SECONDS** the **MOTION**. Commissioner Maglaras invokes unanimous consent. Seeing no objection, the **MOTION PASSES**.

Commissioner Maglaras calls for a voice vote for all those in favor of Commissioner Brian Chirichiello for Vice Chair. The ayes have it and Commissioner Brian Chirichiello is **ELECTED** to the office of the Vice Chair.
 - d. Commissioner Maglaras announces that Commissioner Toni Pappas has been nominated for Clerk. Hearing no further nominations, Commissioner Maglaras closes nominations. Commissioner Maglaras calls for a voice vote for all those in favor of Commissioner Toni Pappas for Clerk. The ayes have it and Commissioner Toni Pappas is **ELECTED** to the office of the Clerk.

- a. Ms. Horgan explains the Association is currently tracking around 300 bills. Ms. Horgan reports that the Legislative Committee is working on recommendations for those bills that have publicly released language.
 - b. Ms. Horgan highlights four bills the Association has asked for: a virtual meeting bill, a bill that updates the county budget process, a bill that allows licensed nursing assistants who take an extra course to receive tuition reimbursement, and a bill to increase the threshold amount for purchases that need to be competitively bid.
